1. Meeting Opening

2. Matters for Decision

2.1. Code Change Topics

2.1.1. Mandatory Cooling of Elder Communities

A document was posted in the portal and members were asked to provide any comments or changes that should be made before the proposed change topic is sent to BSC. It was noted that, if this topic is pursued, it may be incorporated in a section of the code other than 3.8. No changes were noted.

Chris Schamber / Georg Rath moved that the Mandatory Cooling of Elder Communities code change document be sent to the Building Sub-Council and Municipal Affairs for review and potential code change request; CARRIED

2.1.2. Assistive Listening Devices

A document was posted in the portal and members were asked to provide any comments or changes that should be made before the proposed change topic is sent to BSC.

It was suggested that this document doesn't provide enough guidance for BSC about the specific types of buildings and locations/rooms within those buildings. A non-exhaustive list of occupancies in the building code was show and it was suggested that this list be used to provide further direction on where assistive listening devices are thought to be needed. The member representing auditory disabilities will use this list to better define which buildings, and locations within them, the sub-council should propose that assistive listening devices are required, along with rationale for each, for review at a future BFSC meeting. It was suggested that the requirements for a wheelchair accessible section of reception counters could be used as a guideline. The wording within the current document regarding "where important information is transferred" is an important guiding statement to help determine where devices are needed.

2.1.3. Height of Operational Controls

A document was posted in the portal and members were asked to provide any comments or changes that should be made before the proposed change topic is sent to BSC. No changes were noted.

Lee Ramsdell / Georg Rath moved that the Height of Operational Controls code change document be sent to the Building Sub-Council and Municipal Affairs for review and potential code change request; CARRIED

2.1.4. Accessible Parking Stalls

A document was posted in the portal and members were asked to provide any comments or changes that should be made before the proposed change topic is sent to BSC.

A question was raised about the note in the document that the width of accessible aisle can vary from 1200mm to 2400mm, since it's believed that 1200mm is below the minimum. It was noted that abbreviations should be spelled out (ex. TWSI = tactile walking surface indicator) and terminology should be consistent with what's in the Barrier Free Design Guide (ex. curb ramp rather than dropped curb). It is believed that what was posted on the portal isn't the latest version of the document. The correct document will be brought to the September meeting for further discussion and decision. [Lipka/Macklon]
