1. Meeting Opening

The Chair called the meeting to order at 9:01 a.m. A round table introduction was held and members were reminded that their primary duty is to act in the interest of safety in the built environment on behalf of all Albertans.

4. Matters for Discussion

4.1. Nominating Organizations Presentations

Members were surveyed about their interest in different types of presentations. People generally rated the value of general interest presentations as high and the value of specific issue presentations as very high. There was more interest in information about the industry/disability segment rather than nominating organization.

All presentations about industry/disability segments are voluntary and can be done by a member of the nominating organization, not just the member themselves. Any members interested in making presentations were asked to contact the Chair and Council staff three weeks prior to the meeting they want to present at and provide a brief overview of the presentation and presenter. Presentations will be limited to 30 minutes and one per meeting will be held as long as there is space on the agenda.

4.2. Working Group Breakouts

The Awareness Working Group and Technical Working Group each held a breakout session.

4.3. Working Group Reports

4.3.1. Awareness

The group reviewed their outstanding action items during the breakout session and planned next steps.

- Members will be meeting in the next two weeks to discuss getting accessibility info added to MLS listings.
- Members will be meeting to discuss seniors' issues next week.
- The group is working on a condensed checklist of the Barrier Free Design Guide focusing on reoccurring issues. An overview was given of the example from the City of Edmonton that will be used as a template. It was asked whether curb cuts are included in the City of Edmonton accessibility guide and replied that they're not in the example checklist shown but they are in the City's Access Design Guide. Robert will post a copy of the example checklist in the portal for members' information. [Lipka]
- A question was raised about whether SCOs use similar checklists and, if so, whether those could be leveraged as well.

All sub-council members were asked to provide input to the working group if they feel awareness is an issue in their disability segment and if so, to fill out the <u>Questions to Assist in Framing Issues</u> document.

Bev Knudtson will reach out to the member representing Aging Population as well as the incoming member representing Visual Disabilities to discuss the framing questions.

4.3.2. Technical

The Technical Working Group reviewed existing technical code issues during their breakout session, specifically curb cuts, wheelchair mobility issues, and door closures in communal/congregate living settings. Issue with adaptable dwelling units will be discussed at another working group meeting in January. It was noted that the checklist example shown by Robert Lipka could be used as a way to present the issues being seen in adaptable dwelling units.

4.3.3. Assisted Living

It was reported that there is no update from the Provincial Barrier Free Administrator on the recommendations made at the last meeting as the outcome of this group's work. Municipal Affairs staff is currently determining how to incorporate the recommendations into the code. It was noted that this group's work and the sub-council's subsequent recommendations are a key accomplishment.

4.4. BSC Liaison Report

The following topics of discussion from the last BSC meeting were noted:

- BILD Alberta CHBA-National presentation about the upcoming tiered approach to energy efficiency provisions for buildings
- Energy code exemptions in oil & gas industry buildings
- Unvented roof assemblies for Part 9 buildings
- External non-combustible insulation to Part 9 buildings
- Long term use of shipping containers
- Resilient roofing

No items related specifically to the Barrier Free Sub-Council were noted.

4.5. Administrator/AMA Report

It was reported that there is a delay in publishing the upcoming National Building Code, which is now expected to be published in early 2022. If there are any items the group would like to propose for inclusion in the new NBC(AE), the Provincial Barrier Free Administrator requests to receive the recommendations and supporting information by mid-March 2022. It is expected that the NBC(AE) may be published as early as April and would become in force 12 months later. Discussion was held around some of the confusion about the timeframe between publication of the NBC and the NBC(AE) and the subsequent in-force date of the NBC(AE). It was also noted that there may be a transition period following the in-force date.

4.6. Council Updates
