4. Matters for Discussion

4.1. House with Secondary Suite STANDATA

A copy of the draft standata was shared and the following was discussed:

- This standata clarifies that an attached garage serving a house with a secondary suite should be considered part of the dwelling unit and does not require a one hour fire separation.
- This interpretation aligns with the building code's definition of a secondary suite and addresses potential inconsistencies.
- This standata aims to support affordable housing initiatives by avoiding unnecessary and costly fire separations.
- This item will also be brought forward to NRC for consideration in the National Building Code.

4.2. Energy Efficiency Exemptions for Oil and Gas STANDATA

A copy of the draft standata was shared and the following was discussed:

• It was suggested that the category could be broadened to industrial, instead of just oil and gas.

 The Administrator explained that exemptions must be based on the use of the building, not just the type of building.

4.3. CMHC Housing Design Catalogue

The following was discussed:

- Some members expressed concerns over aspects of the designs that do not appear to meet code (decks over living areas, cladding, etc.)
- The final catalogue will have preapproved designs which is intended to expedite the permitting process.
- Local AHJs will have authority over how they administer the permitting process.
