## 1. Meeting Opening

The Chair called the meeting to order at 8:30 a.m. A round table introduction was held and teleconference etiquette was reviewed.

#### **1.2 Adoption of the March 19 Minutes**

Terry O'Flaherty/Stephen Hill moved to adopt the minutes of the March 19 meeting, as circulated; CARRIED

#### 2. Matters for Decision

2.1. Closed Session

Corey Klimchuk/Terry O'Flaherty moved to enter closed session; CARRIED.

The discussion of items 2.1.1., 2.1.2., and 2.1.3. was held in closed session.

Terry O'Flaherty/Grace O'Brien moved to come out of closed session; CARRIED.

#### 2.1.1. Energy Efficient Seat and Nominating Organization

It was decided that members would prepare a skills matrix for a future energy efficiency seat and that would be used for the basis of the decision. Members are also welcome to research alternative options for nominating organizations and bring them forward to the next meeting. [All]

#### 2.1.2. Request for new seat on sub-council

Grace O'Brien/Lee Philips moved to recommend to the Board that a new seat be created for the Refrigeration, Air Conditioning and Heating Association of Alberta; DEFEATED.

2.1.3. Nomination of Justin Pockar to represent Large Municipalities – South

Corey Klimchuk/Terry O'Flaherty moved to recommend to the Board appointment of Justin Pockar to the Building Sub-Council to represent Major Municipalities – South for a term ending January 31, 2023 effective immediately; CARRIED.

#### 2.2. 19-BCB-001 Steel Building Systems

The Administrator provided a revised version of this this STANDATA which aims to define what qualifies as a steel building system. Members provided comments to further enhance clarity:

- There is an implication that schedules/field review is not needed for steel building systems. Schedules from a structural engineer are typically still needed to cover the foundation design and construction, and the erection of the steel building.
- The Standata does not explicitly mention the building envelope considerations (which fall under the architectural discipline) in the considerations for professional involvement/assurance.
- Under the CSA A660 section it lists erection responsibility. Typically erection is done by a third party
- In the section about farm buildings it should say "...the NBC(AE) does not apply to some farm buildings as noted in..."

## 2.3. 19-BCI-000 Integrated Testing Coordinator

The following was discussed:

- A Standard cannot dictate qualifications for a testing coordinator
- This provides clarification on what qualifications are necessary
- The document is supported by APEGA

#### 2.4. 19-BCI-000 Occupancy Classification Supportive Living

The following was discussed:

- Long term care with treatment and without treatment would be handled differently
- Owner/Operator needs to supply intent for how building will be operated
- Suggestion to add a note regarding care occupancy
- Concern that some occupants may fall through the cracks, would like to see further involvement with FSC. Administrator will follow up.

## 4. Matters for Discussion

#### 4.1. Implications of Red Tape Reduction on Permit Approvals

The sub-council was asked for clarity on maintaining processes during Covid. The following was discussed:

- No further disruption since last meeting, seems to be going well
- Most applications are currently online, does not appear to be any delays in permit issuing
- Safety measures have been put in place and remote video inspections are being used where possible

#### 4.3. Definition for Single Family Dwelling

The GSC requested feedback on how BSC defines "Single Family Dwelling" particularly when there is a basement suite in a home that is occupied by people not related to the homeowner. The following was discussed:

- Single family dwelling is not defined terms within the code
- A basement suite is not considered a new unit therefore a single family dwelling could include a home with a secondary suite
- Treated as two dwellings with special characteristics
- Would be called a house with a secondary suite not a single dwelling home

### 4.6. Structural Design of Residential Buildings re. STANDATA 14-BCV-016

The Vice Chair North chaired this discussion.

The Administrator brought forward an updated document for review and the following was discussed:

- The following comments were received:
  - The comment "but may result in structural loads being transferred in magnitudes and at specific points that are not anticipated by Part 9 of the NBC(AE)" is a correct acknowledgement of a concern, but it is not actually addressed by the content of the Standata.
  - "Engineering design software" should probably read "engineered design software". However, you need to be clear what the expectation is on the output from this software. If you expect the output to be as reliable as authenticated project specific professional work product, you should be indicating as much. If not, you should not use the term "engineering" or "engineered" at all as it gives a false level of confidence in the output. The term "approved by an engineer" is not appropriate – either it needs to be authenticated by an engineer or engineering should not be required.
  - There is information requested (beam reactions and beam calculations, for example) that the SCO may not be qualified to do anything with. This implies a higher level of oversight that is achieved.
  - It talks about the qualifications of the designer. The only qualification that would be relevant would be if they were an engineer or not, unless the software provider has a specific training program associated with the use of the software.
  - Page 4, item 1 says that the interface and connection details shall be "accounted for by the designer". These should likely be standard details defined by the manufacturer and applied within their limits.
  - Page 5, item 4.h says that the applicant assumes responsibility for the coordination between manufactured engineered components. It is not apparent that the applicant is qualified to do that. Again, it should rely on standard solutions provided by the manufacturer.

- There are still two items relating to teleposts that should be removed (Page 2 NOTE: and Page 4, 4.f)
- APEGA will be meeting to draft a response, the Administrator will wait to hear their feedback
- Administrator will incorporate comments and bring the document back again in the fall

### 4.8. Working Group Reports

### 4.8.1. Occupant Load

Co-Chair Cameron Bardas delivered a presentation of the group's findings and recommendations. A written report was included in the portal and the following was discussed:

- It was recognized that procedures for calculating occupant loads are inconsistent and challenging to apply
- The working group was unable to reach consensus on harmonization with the National Fire Code of Canada so a revised scope was developed, resulting in the group's final recommendations

Bruce Schultz/Stephen Hill moved to recommend to Alberta Municipal Affairs that a STANDATA be issued to outline the discrepancies between how Occupant Loads are calculated under the Building and Fire Codes (the "Discrepancy STANDATA") to provide broad awareness to owners, operators, design professionals, and AHJs; CARRIED.

It was noted that the Building Sub-Council supports the recommendation that the Fire Sub-Council recommend to Alberta Municipal Affairs a STANDATA be issued on the specific process for Fire AHJs to follow in calculating and communicating occupant loads in assembly occupancies.

## Bruce Schultz/Corey Klimchuk moved to accept the final report and thereby conclude the work of the Occupant Load Working Group; CARRIED.

#### 4.8.2. Breweries and Distilleries

The following was discussed:

- Following up on the recommendations made by the working group in January
- There is currently a change request in front of the NRC to move distilleries to an F2
- AMA will issue a Notice at this time and will review if a STANDATA is still necessary based on the NRC's decision

- AMA has requested and is awaiting reports on 8 structural failures on houses all the same builder. SIPS
