4. Matters for Discussion

4.1. AGM Update

The following was discussed and a presentation is available in the portal

- Safety Codes Council AGM was postponed this year due to Covid-19 and plans are being made to host it virtually towards the end of October
- Need to hold the AGM to approve the bylaw changes that were recommended as a result of last year's governance review
- A refresher of the recommendations was provided: dissolve the TCC, creation of two new sub-councils for Utilities and Private Sewage Disposal Systems

4.2. Council Education Presentation

A presentation by Kris Schmaltz and Michael Lalonde was included in the portal and the following was discussed:

- The Council is reviewing its approach to education and training in the system and has developed outcomes and principles to guide programming
- Looking for stakeholder feedback on the proposed future direction of building capacity system-wide through shared understanding and knowledge, and any gaps anyone sees regarding education in the system.
- Targeting a broader system-wide audience could improve shared consistency in understanding of roles, responsibilities, and general knowledge in the safety system
- There is a gap in the industry for code related training for professionals
- Suggestion to look at APEGA and AAA's professional development guidelines
- Information on the entire process (ie. working with AMA, STANDATAs, Safety Codes Council, etc.) would be helpful to stakeholders and nominating organizations
- Need to ensure people in the field are receiving the right education
- Focus on parts of the code which consistently have variation in interpretation

4.3. Letter from ABOA regarding Ilim Nordic Timber

The following was discussed:

- Lumber incorrectly being stamped as structural lumber
- People checking it should be aware that this is not acceptable lumber for structural use.
- Letter provided for information, please distribute widely

4.4. Alternate Solutions for vented roof spaces

The following was discussed:

- Administrator looking for clarification on why the proponents were sent away with minimal technical concerns but with criticism over the process as compared to a similar request for thin masonry veneers which was accepted
- There was a case for alternate solutions but no industry guide backing it, not clear who
 would be responsible for the use of this solution
- It was noted that the code does allow for AHJ interpretation, however the proponents were looking for a province wide solution

4.5. Structural Design of Residential Buildings re. STANDATA 14-BCV-016

Russell Croome chaired the discussion.

The following was discussed:

- The Administrator is reviewing information from APEGA and other stakeholders, not able to produce the STANDATA at this time
- Municipal Affairs looking into how this was developed and if there were unintended consequences
- APEGA has written to AMA to express concern with engineering design software being operated by non-professionals
- Software is capable of much more than when this was originally issued, need to ensure the rules are keeping up with the available technology
- It was noted that the existing STANDATA has not been withdrawn, it just has not been updated with the code cycle

- Building and Electrical Administrators reviewing application of CSA-B72 as referenced in the Building Code to lightning protection systems, which when installed is under the electrical discipline.
- AMA has identified 819 variations from the NBC, working through those to get closer to harmonization
- Some of our technical advisors have applied to be part of the National Barrier Free Technical Committee (this is not NRC)
- Updating online application for barrier free relaxation to be more user friendly
