It was questioned regarding the STANDATAs that have already been endorsed by the sub-council but no longer included on the action list. It was clarified that these are in final review by the Director of Codes and Standards and will be issued in the next week or two.

4. Matters for Discussion

4.1. Plumbing Sub-Council review of unintended consequences /challenges of the NECB Re: insulation requirements effect on the hydronic heating industry

David Hughes, Chair of the Plumbing Sub-Council (PSC), was welcomed to the meeting and reported on concerns on behalf of the PSC and the Canadian Institute of Plumbing and Heating. The ABC 2014 – Section 9.36 Prescriptive Energy Efficiency Requirements for Houses is having a significant impact on the hydronic heating industry, specifically in-floor heating systems. These new energy requirements go well beyond the requirements of CSA B214.

This new requirement will only save about \$25.00 per year for a 1,500 square foot home. Installation of 4" thick insulation will take up to 147 years to recover costs. The Return on Investment just isn't there.

Hydronics Industry is feeling unjustly targeted. Based on a recent poll of the industry:

- 77% decrease overall
- 90% decrease for new installations
- 95% has affected their industry

CIPH is looking for a relaxation of the code of the R25 energy code requirement. Electrical in-floor heating would have the same requirements. Ontario requires minimum R10, instead of R25. It was noted that in Alberta this would require a Ministerial Exemption Order, a change to the code or a trade-off to ensure equal energy savings.

CIPH will be presenting a proposed change to the National Building Code and is looking for the Building Sub-Council's support. CIPH is not opposed to insulation but the question is when is too much and doesn't create any return on investment.

It was reported that in Calgary, 60-70% of single family homes are using the performance path through modelling and engineering would not be required. Calgary is seeing applications with only 1" insulation for in-floor heating.

It was questioned that if equivalency can be proven, could a province-wide variance be considered. The Building Administrator reported that this could be looked at but uncertain of whether that would be possible.

David Hughes will send the letter and information to the Manager of Stakeholder Relations to have included in the Building Sub-Council portal. [Hughes / Rossmann]

Bruce Schultz / Kenneth Roskell moved that the Building Sub-Council supports a code change request to be drafted and submitted by the Canadian Institute of Plumbing and Heating to change the prescriptive requirements for insulation under basement slabs where heated floors are installed, on the basis on its unintended consequences to industry; CARRIED

4.2. Permit Regulation Review Schmaltz

Kristopher Schmaltz and Colin Robertson were welcomed to the meeting and provided a presentation on the Permit Regulation Review:

- Expiry has been extended to January 2019
- This is the initial consultation to gather feedback on principals and potential changes that may be needed to the Permit Regulation
- Beginning with defining what a permit is and what it is not
- Overview was provided of the scope and principles
- Scope of the review
 - Reviewing the policy objectives of the regulation
 - Identifying issues, challenges and gaps
 - Identifying solutions through policy, amendments or other adjustments to the safety system
 - Reviewing technical requirements for each discipline

The following questions were asked:

- 1. Issues or challenges with the Permit Regulation?
- 2. Are we requiring permits for the right things?
- 3. Are we permitting too many things or not enough?
- 4. When should permits be required or not be required?
- 5. What is the value / benefit of permits?

The following feedback was provided:

- Public perception is that a permit is everything that was on the 'A Permit is Not' list...so there is a large public perception that needs to be overcome; there may be a need to strengthen language to ensure that it is clear; there needs to be collaborative understanding
- The Permit Regulation should have more flexibility because municipalities are currently having to work around the rules to extend the permit, timelines of permit should be left up to the authority having jurisdiction (AHJ), permit regulation could possibly have a model time guideline with the addition of "or at the discretion of the authority having jurisdiction"
- It was suggested that perhaps the Permit Regulation and compliance monitoring be separated; there is a need to ensure the consumer has confidence in the system; they believe that permit and compliance are one in the same; the green sticker means something to the consumer that everything complies and that's not often the case
- Reroofing / residing permit is not required if using the same material, but this often

causes a challenge – suggested this be left to the AHJ, or different types of permits – with or without inspection

- Matters affecting health and safety should be expanded a bit as it creates unnecessary conversations
- Window replacement should be added as there could be circumstances were there are higher risks (e.g. spatial separation, etc.)
- It was suggested that the regulation contain simple language to increase better understanding
- AHJ should be able to manage the risk in their jurisdiction

It was questioned whether discussions are being held regarding "who" can take out permits. It was clarified that this is based on certification. This also led to a discussion regarding homeowner permits.

4.3. Code change proposals to address immediate safety issues - Bedroom Window Limiters

It was reported that there have been increased instances of children falling from residential bedroom windows. A Code Change Request was submitted in 2015 and has sat dormant with NRC since then.

An in-depth discussion was held on the matter and it was agreed that if there is a significant safety issue, the Council has an obligation to inform the Minister. It was noted that a case would need to be built including the rationale to make recommendation to the Minister, through the Board.

Bruce Schultz will provide the Council with the initial Code Change Request to be included in the portal and will provide a presentation at the next meeting. [Schultz / Rossman]

4.4. Plan and process to discuss proposed NBC changes and overlap with AFC

Bruce Schultz reported that the public review of the National Building and Fire Codes will be available this fall but it is understood that AMA will receive this information in advance. The Fire Sub-Council (FSC) is suggesting that a joint working group be created to review proposed changes to the national codes that affect both disciplines.

It was also reported that the FSC would like to provide feedback on both Building and Fire. It was suggested that with more involvement in national changes, this is so quite relevant discussion that is needed to determine a process of moving forward considering code harmonization.

Andrew Smith / Mark Brodgesell moved to establish a Working Group to review code changes to the 2020 National Building Code proposed changes; CARRIED

The following members volunteered: Bruce Schultz (Chair), Mark Brodgesell, Russell Croome and Rick Gratton. It is understood that this would be a BSC Working Group that could work with the FSC to share comments and concerns on common issues.

The Working Group will establish terms of reference for approval by the BSC by Letter Ballot. [Working Group / Thomas]

4.5. Spray foam hybrid assemblies

It was reported that industry has a desire to use hybrid assemblies to reduce costs but some AHJs are not accepting them. It was reported that a ULC working group is reviewing the Standard and will be updating it for clarification. As it is low risk and not a life safety issue, AHJs are not asking for it to be removed.

Bruce Schultz / Bob Zifkin moved to request that the Building Administrator review and consider the issuance of an Information Bulletin to create awareness of the issue of Spray Foam Hybrid Assemblies (combination of ½ lb and two lb); CARRIED

It was suggested that the information on the Airdrie Bulletin could be used as the basis for an Information Bulletin.

4.6. Municipal Affairs Report

4.6.1. STANDATA Review

4.6.1.1.BCI-XXX Photoluminescent Exit Signs

The draft STANDATA was included in the portal and reviewed. The Chair reported on a letter received yesterday from the Electrical Sub-Council regarding this STANDATA as well as the STANDATA already issued regarding visual signals.

The letter from the ESC will be circulated for consideration by the Building Sub-Council.

An overview was provided of the issues and the need to issue an interpretation to provide clarification regarding the required illumination of photoluminescent (PL) exit signs according to Articles 3.4.5.1 and 9.9.11.3. of the Alberta Building Code 2014 (ABC14).

Mark Brodgesell / Bruce Schultz moved that the Building Sub-Council has reviewed concerns expressed by the Electrical Sub-Council and support the Building Administrator in publishing the STANDATA as written; CARRIED with one noted opposition – Russell Croome

4.6.1.2.BCI-XXX Non-Liquid Disposal Systems

The draft STANDATA was included in the portal and reviewed.

It was suggested that the first sentence under Application needs to be reworded for better clarity. Clarification was sought regarding the use of Non-Liquid Disposal Systems being used as part of the fixture count. It was the opinion of the Building Administrator that this would require a code change request. The Building Administrator will review the May 2014 minutes, reword the Application and a revised draft will be brought back to the sub-council. [Chang]

4.6.1.3.BCI-14-XXX Attached Garage Insulation

The draft STANDATA was included in the portal and reviewed. An in-depth discussion was held regarding unconditioned space. It was noted that this interpretation is required because of the HIRF requirements not an energy code requirement. Suggested rewording was provided.

The Building Administrator will provide a revised draft to the sub-council. [Chang]

4.6.1.4.BCI-14-XXX/PIB-14-XXX Soil Gas Vent Termination

The draft STANDATA was included in the portal and reviewed. It was questioned regarding Building Permits and clarified that only an Electrical Permit is required as this is only addressing termination. It was questioned regarding (g) underneath a veranda, porch, or deck and suggested that reference be included regarding no enclosed space.

Mark Brodgesell / Kenneth Roskell moved to support the issuance of the STANDATA as revised; CARRIED

4.6.1.5.BCB-14-XXX/PIB-14-XXX Radon/Soil Gas Pipe Labelling

The draft STANDATA was included in the portal and reviewed. The Building Administrator will review the Standard for labeling and will include any additional information in the STANDATA if needed.

Bruce Schultz / Ulrik Seward moved to support the issuance of the STANDATA with the comments provided; CARRIED

4.6.1.6.BCB-14-XXX Permit Application for a Building with MultiUnits

The draft STANDATA was included in the portal and reviewed. It was suggested that this STANDATA should be reviewed along with the STANDATA on stacked townhouses. It was questioned regarding duplexes as one municipality does require two separate building permits.

Further discussion was deferred until the other STANDATA is available.

4.6.1.7.BCV-14-XXX ABC 2014 Bonnyville Heating Degree Days Update

The draft STANDATA was included in the portal and reviewed. After a brief discussion, it was agreed that the STANDATA was not needed and it was withdrawn.

4.6.2. Building Code Interpretations

It was reported that Calgary is getting applications for grow-ops. There is a need for a discussion relative to energy codes, building classification, etc. This item will be added to the next agenda. [Dessario / Council Administration]

The Electrical Sub-Council has expressed concerns regarding visual alarms and this will be reviewed by the Building Administrator. [Chang]

4.7. 2015 NBC Code Cycle - Update on Code Harmonization

It was reported that there is no further information from AMA regarding the Council's recommendation to skip the 2015 National Building and Fire Code cycle. It was noted that during regional meetings, there was overwhelming support in favour of skipping a code cycle.

It was clarified that nothing has been heard regarding an early adoption of the NECB.

It was noted that even if a code cycle is skipped, there is still a need to review the 2015 codes for the purpose of harmonization.

4.8. BSC/FSC Liaison Report

The following report was provided from the last FSC meeting:

- The review of harmonization between 2015 NFC and 2014 AFC is almost finished
- Concerns are being expressed regarding temporary heat in construction and furnace manufacturers that have stated the furnace cannot be used for temporary heat during construction. However, other sources have higher fire hazard risks.

Still waiting for draft of Food Truck Standard from NFPA

4.9. BFSC Liaison Report

It was reported that the Barrier Free Design Guide has been delayed due to a lack of resources at the Council. A brief update was provided regarding adaptability to accommodate accessibility at hotels that is being looked at and this could form part of the guide.
