

## COUNCIL FEE SCHEDULE: OPERATIONS

### 1. Accreditation

Accreditation	Fee (per discipline)
New accreditation application	\$150 <sup>1</sup>
Scope change application	\$150 <sup>2,3</sup>
Organization name change application	\$100
Update accreditation application	No fee
Reinstatement from suspension or cancellation	\$150 <sup>3</sup>

1. For a new joint accreditation application, one fee per discipline will be charged regardless of the number of municipalities participating. The subsequent addition of a new member municipality will be deemed a new application.
2. A fee shall not be charged for a change in the fire discipline respecting tank management.
3. The Council may adjust or waive a scope change or reinstatement fee taking into consideration the specific circumstances related to the application. The rationale for adjusting or waiving the fee will be documented.

## 5. Certification of Safety Codes Officers

New application	\$75 <sup>1</sup>
Prequalification review	\$50
Renewal	\$75
Reinstatement from expiry	\$100 <sup>2</sup>
Reinstatement from suspension	\$150 <sup>2</sup>
Reinstatement from cancellation	\$100 <sup>2</sup>

1. A joint plumbing and gas discipline application is a single fee.
2. The Administrator shall consider a reinstatement request and may adjust or waive the reinstatement fee taking into consideration exceptional circumstances.

## 6. SCO Designation of Powers

Designation of Powers	Fee (per discipline)
New application	\$100 <sup>1</sup>
Permit issuance only	\$50 <sup>2</sup>
Amendment	\$25 <sup>3</sup>
Reinstatement from suspension	\$100 <sup>4</sup>
Reinstatement from cancellation	\$100 <sup>4</sup>

1. The fire discipline is exempt from the new application fee; a joint plumbing and gas discipline application is a single fee.
2. Permit issuance fee is per application and may cover more than one discipline.
3. Includes changes to an organization's name or SCO scope of authority.
4. The Administrator shall consider a reinstatement request and may adjust or waive the reinstatement fee taking into consideration exceptional circumstances.
