The current CE Code requires either a certified kit or 2.5 inch rigid steel conduit, but there's no evaluation on using the rigid steel with the other kit components. There is also a variance STANDATA allowing smaller rigid conduit. Anecdotally, there are fall-downs of masts. Further info will be brought by the WG chair at a later meeting.

4. Matters for Discussion

4.1. Conflict with Utility in flood areas

Some jurisdictions are noticing a conflict between the utility's guidelines and the CE Code regarding the height of meters and moving them above floodplains. This is especially an issue in commercial applications as there can be a great deal of electrical equipment below grade. Discussions have been held in the City of Edmonton and EPCOR is taking the issue back to its management/engineering department. It is likely a more significant issue in the City of Calgary as they have a significant flood plain in the city centre

CE Code Section 6 says service equipment must be above the floodplain, but in many cases it's not feasible for the utility to put the equipment that high up. There is also reference to the equipment location being acceptable to utility.

The acting Provincial Electrical Administrators will bring forward any further feedback.

4.2. Working Group Reports

4.2.1. Low Voltage Lighting

There is nothing to report as the working group chair is not in attendance.

4.2.2. Colour Coding

There is nothing to report as the working group chair is not in attendance.

It was noted there is a current STANDATA that reminds users that using yellow/orange/brown is not allowed by the CE Code and gives guidance on how to address existing installations that do use these colours.

4.2.3. Non-Metallic Outer Jacket Cables

At last meeting, the working group was asked to review feedback from ESC and make changes to their proposal. Revisions will be brought to a future meeting.

4.2.4. Energy Storage

A completed variance STANDATA proposal was viewed on screen and reviewed. Background information was provided on the issues that the draft STANDATA content intends to address:

- Traditional lead acid systems are being treated similarly to lithium ion systems and are being required to adhere to rules they never had to before.
- "Electrical equipment vault" was changed to "service room" as this is better
 defined in the CE Code and NBC(AE) to match the intent of a 1-hour fire rating
 and smoke detection in that room.
- Clear limitations would apply if installing an energy storage system within a dwelling.

Editorial changes were suggested to clarify smoke alarm requirements in addition to those required by the NBC(AE). The member representing Solar will make the changes and circulated a revised draft. [Knaggs]

This proposed variance is based on changes that are believed to be forthcoming in the 2024 edition of the CE Code. It was asked whether there is any information from CSA committees about how these proposed code changes are progressing through balloting. Tim will bring this information to the next meeting.

4.2.5. Single Family Dwelling Definition

This working group has been revived based on interest from other sub-councils, notably BSC. The group is looking for alignment across all disciplines and will meet in the future to define the root issues in each discipline that are arising from the way the definition is currently written.

4.3. Liaison Reports

4.3.1. Building

The last meeting was September 22, 2022, and nothing relating to the electrical discipline was discussed.

4.3.2. Electrical Utilities

The last meeting was at the end of June and nothing relating to the Electrical Sub-Council was brought forward. The next meeting is October 21, 2022.

4.4. Administrator/AMA Report

The acting Administrator reported on the following:

- Clarence Cormier has resigned as the Provincial Electrical Administrator and accepted a
 position with Nova Scotia Power. The vacancy is expected to be filled permanently in
 the coming months. Kevin Glubrecht will be acting Administrator for the month of
 October.
- Recently published STANDATA:
 - o 21-ECB-002 (REV1) Section 2 : General rules
 - Information added regarding the use of replacement breakers in panelboards
 - 21-ECB-004 (REV1) Section 4 : Conductors
 - Added information on how to deal with installations using orange/yellow/brown (OYB) conductors to differentiate between different voltages.
 - o 21-ECB-010 (REV1) Grounding and Bonding
 - Added information related to the bonding of fuel tanks and reference to the NFC(AE).
- STANDATA currently being updated:
 - 18-LEG-ECR-002 Section 2 : electrical systems equipment
 - 3rd hyperlink added to Standards Council Website showing images of updated certification markings
 - Certification and Permit Regulation Legislation
 - Update broken links, and change Alberta Queens Printer to Alberta Kings Printer
 - Permit Regulation Legislation
 - Update references to Alberta Kings Printer
- The Apprenticeship and Industry Training Act has been repealed and replaced with the Skilled Trades and Apprenticeship Education Act. Regulations under this act have also

been adjusted. The member representing Education and Training reported there have been substantive changes to the act that are being adjusted to.

4.5. Council Updates

A written report was included in the portal and updates were provided on the following:

- Members were reminded of the recent update to the Council's communications policy which now is applicable to members.
- The Council's AGM and volunteer appreciation event is being held in Edmonton on October 21, 2022.

- Clarification was provided about the approach to in-person and virtual sub-council meetings.

5. Meeting Finalization

5.1. Round Table

- Contractors are seeing solar panels that don't appear to be CSA approved. The member representing Solar will assist other members with this.
- A recent fatality, believed to be due to electrical shock, in a hot tub in Canmore was brought up. It was clarified that ASCA was not involved in the fatality investigation but did send an Electrical SCO to ensure that the site was safe. It's unknown what further action may result because the investigation is not yet complete.
- Changes to Standard 0, the product standard that applies to all Part 2 products, were
 published in April. There is now the option for any manufacturer to test any product and
 mark it for above 75 degrees. There is also the option to use QR codes or websites for
 non-required information/markings. There will be an awareness component to these
 changes and the member representing Manufacturers will assist with this.
- Discussions continue at CSA technical committees regarding a proposal to Section 0
 allowing ingress protection marking only, which is a significant issue for hazardous
 locations. Energy management systems and appliances with only ingress protection
 markings are being installed.
