4. Matters for Discussion

4.1. Part 1 and Part 3 Overlap/Jurisdictional Issues

The following was discussed:

- An example was shared of a utility giving direction on an item that falls under Part 1 of the code.
- While companies can provide best practices, it is not possible for SCOs to enforce above and beyond the code.
- There may be quite a few installation guides that do this and it would be helpful to have them identified, especially as we move towards harmonization.
- Would be good to know if the utility guides are not in the terms of service as those are approved with utility rate applications.
- Members were asked to think about any similar overlap or jurisdictional issues they may come across and bring them forward to the Chair or Council staff for discussion at future meetings.

4.2. Working Group Reports

4.2.1. 2022 AEUC Development

- The following was discussed:
 - A working group was previously created under the Electrical Sub-Council to review and recommend changes to the code. Reviewing those recommendations will now fall under this sub-council.
 - There will be a final draft available on the portal for members to review. Please feel free to track your changes in that document or send them to Council staff for compiling.
 - A draft will also be provided to Municipal Affairs staff for review simultaneously to expedite the process.
 - This will be reviewed in depth and voted on at the next sub-council meeting in April.
 - Please note that there is an ongoing effort to harmonize with the national code and any deviations need to be heavily supported with additional information.

- SCO Scope
 - Alberta Municipal Affairs (AMA) regulates the Safety Codes Act (SCA), associated regulations, adopted codes, and referenced standards which serve as a minimum set of prescriptive requirements for electrical installations in Alberta. Voluntary installations that go above these are allowed but are not enforceable by the local Authority Having Jurisdiction (AHJ).
 - o Bylaws
 - SCA 66(1) Except as provided in this section, a bylaw of a municipality that purports to regulate a matter that is regulated by this Act is inoperative.
