4. Matters for Discussion

4.1. Occupant Load STANDATA

A revised STANDATA that reflected feedback from other stakeholders was posted in the portal and will be brought to BSC as well. The Provincial Fire Administrator requested that members review the revisions and bring forward any proposed changes to the May FSC meeting for discussion. If no feedback is received from the sub-councils, the STANDATA will be published as

is. Members were invited to submit comments to the Administrator ahead of time so they can be considered prior to a full discussion at the May meeting. It was clarified that this draft can be shared with nominating organizations as well.

4.2. Working Group Reports

4.2.1. Code Review

This item was chaired by Mike Bos.

The following was discussed:

- The group met the day before the FSC meeting and a written report is being developed.
- There is the opportunity for more members to get involved because of members leaving the sub-council.
- Input is being gathering from other groups such as the Fire Marshals Guild and City of Calgary. The Guild provided feedback on a number of code items for which they believed harmonization would present minimal impacts and should be harmonized (these will be itemized in written report).
- o Additional AMA support was offered to assist with the workload.
- A question was asked about the process for submitting code change requests. The code change requests being developed by the working group will be brought to the FSC for approval and AMA will support the code change requests that are proposed by the FSC. It was noted that individuals and other bodies (ex. municipalities) can submit code change requests directly to NRC as well.

4.2.2. Exterior Insulation

No update is available as the working group chair is not in attendance.

4.2.2.1. Additional member requested

Mark Heiderich volunteered to participate and noted this is an important topic in the insurance industry.

Mike Bos / Glenn Baxter move to appoint Mark Heiderich to the Exterior Insulation Working Group; CARRIED

4.2.3. Shipping Containers

The Working Group has narrowed down use classifications and risk levels within the risk matrix they are developing and are working to fine tune what is appropriate within each category. The final report is expected for the May 19th meeting.

It was noted that the type of use/occupancy will determine whether it is considered a building or a storage container. What can be stored and what uses are permitted will be included in the risk matrix document that will be brought forward. The working group is aware that land use bylaws could be used to manage containers used as buildings but are focusing their discussion on application of the building and fire codes.

4.3. BSC Liaison Report

There was no report as BSC hasn't met since the last FSC meeting.

4.4. Reference Standards

4.4.1. NRC Fire Protection

This group will be meeting in May. Mark Heiderich offered to share the meeting details with any interested members as it is open to observers.

4.5. Administrator/AMA Report

The Administrator reported:

- AMA is awaiting national code publication.
 - The timeline from publication of the national code to publication of the NFC(AE) is hypothetically 6 months, but it depends on what is happening with development of the NBC(AE) and any alignment implications. It is believed the next Alberta Editions will be published before the end of 2022.
 - Much of the work involved with the development of the next NFC(AE) is within Part 4.
- AMA staff will be returning to the office by April 4 at the latest.

4.6. Council Updates

A written report was included in the portal and updates were provided on the following:

- The Council office is reopening March 14.
 - Staff may work from home on some days.
 - The May meeting is planned to be held in person and Council staff are working on defining what in-person meetings will look like. Staff will contact members as soon as possible to communicate information and assess comfort levels.

If over half the members plan to participate virtually, the meeting would be adjusted to be entirely virtual to allow for easiest facilitation and participation by all.
