4. Matters for Discussion

4.1. QAF Presentation

This item was deferred to the fall.

4.2. PTMAA

The Administrator reported that after a review by the Agency Board and Commissioner it was recommended that PTMAA duties be transitioned to the Safety Codes Council (ASCA). There will be a couple of STANDATAs released in the next couple of weeks detailing the transition (effective June 8th) as well as information on storage tank inspections. An additional STANDATA regarding qualifications for installers, removers, etc. is expected in August. There will be further consultation

on how to improve the system in the fall and the FSC will be a part of that process. If anyone has any questions please contact the Administrator or Charles Hallett with the Safety Codes Council directly.

4.3. Fire Variances

Members were asked to review the document and bring back any feedback for how the information can be used going forward. The following was discussed:

- The information is helpful to identify recurring issues
- Members were unable to access "document" tab which would have provided additional information
- Not necessary to maintain information more than one code cycle back
- Would be helpful to know which jurisdiction approved it and the rational for how the minimum requirements were achieved

It was noted that it would be helpful to compile variances issued from January 1, 2020 and spanning the next few years. Additional information regarding the reasons as well as any expiries would be useful as well. The Administrator will look into this further.

4.4. Cannabis and the Insurance Industry

There is not a lot of data yet on how cannabis risks are being insured, each company is assessing it on a case by case basis. Industry is concerned about the risks, which they feel could be very high. Companies are focusing on security measures, quality control, regulatory compliance, business interruption costs, and long term health effects. Most are allowing cannabis to be grown in a personal residence as long as proper licensing and permits are in place. However, the client must let the insurance company know any time there is a material change in risk to their property in order to be covered.

4.5. Working Group Reports

4.5.1. Occupant Load

- A written report was included in the portal and the following was discussed:
 - It was recognized that procedures for calculating occupant loads are inconsistent and challenging to apply
 - The working group was unable to reach consensus on harmonization with the National Fire Code of Canada so a revised scope was developed, resulting in the group's final recommendations

Cammie Laird/Gary Mayorchuk moved to recommend to Alberta Municipal Affairs that a STANDATA be issued to outline the discrepancies between how Occupant Loads are calculated under the Building and Fire Codes (the "Discrepancy STANDATA") to provide broad awareness to owners, operators, design professionals, and AHJs; CARRIED.

Gary Mayorchuk/Robbin Foxcroft moved to recommend to Alberta Municipal Affairs a STANDATA be issued on the specific process for Fire AHJs to follow in calculating and communicating occupant loads in assembly occupancies; CARRIED. Cameron Bardas was opposed and Allan Blatz abstained from voting.

4.5.2. Code Review

The following was discussed:

- There were a few items that came up which were related to farm building code references
- It was reported that the Minister is currently reviewing a notice regarding harmonization, public review is complete and comments are being reviewed this week
- It was proposed that the working group meet again to discuss which items are looking towards harmonization and which are Alberta specific

- The Administrator reported that a Notice will be issued at this time, instead of the recommended STANDATA
- It recently came to her attention that there is currently a code change request in front of NRC in regards to distilleries so it was decided to issue a Notice at this time and revisit in the fall
