 - Update for ULC 636, this will be important because of the challenges between appliance standards and venting standards
 - \circ $\,$ Ongoing challenges with hydrogen and blending in the Canadian system $\,$
 - 2%-9%
 - Once you put 10% hydrogen into a blended application is looks and acts like hydrogen
 - Decisions being made in areas like utilities, alternate fuels, transportation are going to create some hydrogen challenges we haven't had to consider before
 - Challenges to field approval versus charging of the utility and the relationship with local AHJ's
 - o Remote inspection procedures, lots of ongoing conversations in this area
- UL/ULC 2200 published September 29, 2020
 - This is the certification standard that is the companion for the Engine Variance and Bulletin previously discussed
- B108.1 and B108.2 currently in final balloting with the IGAC
 - Anticipated publication January 2021

- B109 completing part 1/part 2 development.
 - Anticipated Public consultation January 2021
- North American hydrogen discussion of mirror committees reporting to ISO (similar to DME)
- Gasfitter reconciliation at national discussions of PTAC, working towards ensuring there is trade and labour mobility for gasfitters across Canada

4.7. Unpermitted Work

Charles Hallett and Peter Thomas from the Safety Codes Council explained that they have received requests from various agencies to investigate best practices regarding unpermitted work. Members were asked for input on how they handle the issuing of permits post construction. The following was discussed:

- In Fort McMurray they will sell permits as long as the homeowner is willing to open everything up (ie. walls, etc.) as required by the SCO. Would be a liability issue to permit what cannot be seen. Charge double the fee when issuing, however most homeowners choose not to proceed. Also recommend homeowner investigate title insurance. Not as common in industrial settings and if so, the work is usually exposed so just charge double the fee.
- Municipal Affairs advises homeowners to work with AHJ to rectify if you realize you are noncompliant, advise to expose if necessary or provide evidence (ie. photos) in order to manage risk.
- Committees at national level are working on similar issues; addressing alterations to existing buildings
- From a consumer protection standpoint there were concerns about how to assist a homeowner who discovers work was unpermitted
- Perhaps could involve realtors in the process, have previous owners sign a waiver stating that no unpermitted work has been completed.
