1. Meeting Opening

The Chair called the meeting to order at 9:03 a.m. A round table introduction was held and the primary duty of Council Members was reviewed.

2.2. Single Family Dwelling Definition

A joint working group was established with the Electrical Sub-Council to develop proposed revisions to the definition of Single Family Dwelling in the Permit Regulation. The work of the group was reviewed on screen and the following was discussed:

- The term 'a parcel of land' was reviewed as it is unclear how that phrase effects the definition.
- It was suggested that the group could focus on defining their intent to limit it to only one dwelling unit (i.e. excluding secondary suites) rather than the specific wording of the definition.

- It was noted that this is a proactive review in anticipation of the Permit Regulation being opened in the spring. It will take approximately six months from public review to being considered by the GOA.
- Input from other sub-councils was requested.

Roy Herrington/Larry Miller moved to have this wording put forward to the other sub-councils for their review and consideration; CARRIED

Council staff will circulate the proposed definition to other sub-councils for a proposed agenda discussion item. [Council Administration]

2.3. 14-BCV-007 Interior Stairways for Roof Access

Past discussions were held about this building STANDATA being revised to contain information that relates to the gas discipline to identify roof access required by CSA B149.1. A document will be posted and reviewed at the next GSC meeting, including the 2019 and 2014 versions and the February 2021 proposed changes, so the sub-council can make recommendations.

Item will be added to Matters for Discussion at the next GSC meeting.

2.4 Combination Heating STANDATA

The Combination Heating STANDATA has been moved to the new STANDATA template and is still in legal review at Municipal Affairs, but the technical information is complete. This STANDATA could be supported by the sub-council for the technical component with the final document coming back as information or a decision can be delayed until the document is complete. There has been communication between the Administrator and the Canadian Propane Association asking them to consider going to Municipal Affairs to estimate jurisdictional challenges that affects the federal regulator. Those communications will be shared with the chair of the GSC.

4. Matters for Discussion

4.1. Gas Fitter Trade Scope for Process Fired Equipment

There is a need for clarification of the scope of the gas fitter trade as it applies to installation, maintenance and alterations to gas fired equipment that is operated as part of an oil and gas, refining, or petrochemical facility by an accredited corporation. It's unclear what the role of the gas fitter is in managing different kinds of equipment and what the regulatory requirement is for managing this equipment. Background information was provided and reviewed on screen.

Discussion included the following:

- In the electrical trade, you get training on wiring of gas appliances but no gas code training or wiring. Electricians don't receive enough training to wire a B149.3 appliances from scratch. Training should be reviewed and trades should work collectively.
- It is gas fitter work but it also falls under other trades. Everyone needs to work together and the appropriate permits need to be in place.
- Any recommendations, discussions or action from this discussion should be sent to the apprenticeship committee.
- It would be nice to have more clarity on what the expectations are. Some process plants may employ gas fitters but it's not an expectation. Based on specialized skills of other trades, it is clear how this is applied to them but it's not clear with gas piping.
- Inspections don't review the wiring, they look at what the gas fitter is responsible for.
- Many gas fitters feel they have enough overseeing and they don't want to have another code to worry about.

- The fuel gas pressure piping in plants (20-GCB-10 rev 3) STANDATA provides some clarification as to where the gas fitter jurisdiction starts and where the pipe fitter/steam fitter starts.
- We can't expect a single trade to manage this kind of complex process equipment. It helps to hear different perspectives.

4.2.3. CSA-B149.3.2 /CSA B149.6

There has been conversation around the CSA RFP for B149.1, B149.2, B149.3, B149.5, B149.6 around accommodating climate change adaptation. The RFP requires stakeholder engagement that will start in September, the working group has had specific discussions with how the GSC could be involved.

It was noted that if any sub-council members would like to participate as individuals, they can send Justin Trupp their contact information. Members were reminded that if they do sign up to be a stakeholder, they would not be representing the sub-council. Council staff and the Chair will discuss the possibility of the sub-council as a whole participating.

CSA B149.6 2020 has been recommended for adoption. There seems to be a willingness from the Government of Alberta to adopt the BNQ 1784.000 and B149.6 codes, but there is no known timeline for this. It was questioned whether the sub-council should be proactive in its review of these codes or wait until final codes are received. It was noted that because members are volunteers, we want to ensure work being done is providing good value to the safety codes system.

- Hydrogen/natural gas blend is being reviewed.

4.6 Venting an Outdoor Heating Unit

The manufacturers/suppliers industry segment representative brought forward an issue around adding venting to outdoor heating units in commercial industrial settings. It was explained that the installation code is specific to indoor units and some customers do not want to mount on the inside or on the roof for aesthetic reasons. As a manufacturer, there isn't much that can be done once the product leaves the store and certification is limited to what is already been tested. It was asked what can be done to accommodate customers who want to add a chimney.

It was noted by the Administrator that this can be done, however work may need to be accompanied by a variance request. The codes do not restrict vents being installed outside in accordance with vent manufactures installation. There are lots of prescriptive requirements in the code and without knowing the specifics, it's hard to give a definitive response.
