ASME Code Committee Activities

The next ASME code week will be in Atlanta, Georgia, November 11-16, 2018. This is the last meeting to discuss and potentially accept changes for the 2019 edition. Many items have been completed, but some items have issues that are still being resolved.

4.2. AMA Report

The Technical Advisor reported on some of the activities he's been involved with recently:

- Power engineer certification challenges across different jurisdictions
- Working with AWOC on Pressure Welder Regulations

A three-column document was circulated regarding the General Application on Alberta OH&S Guidebook, what went wrong at Fernie and who is responsible. It was reported that the Advisor has reviewed the guidebook and picked out what he believed to be the most relevant. Members were reminded that Alberta does not regulate refrigeration in the same manner that other provinces do.

During an in-depth discussion regarding the document, the following was noted:

- Change to a 4-column document with the following headings
 - o OHS Requirements
 - o What went wrong in Fernie
 - Who in Alberta would be Responsible
 - Learnings, Preventative/Corrective Action
- There was general consensus that the major initiative should be to ensure management making financial decisions about these plants are aware and understand the safety risks inherent with ammonia refrigeration plant operation, and that the PESC should understand the regulatory framework that can provide assurance the people responsible for operating these plants are aware of the risks and how to effectively manage them.
- An entry level refrigeration operation certification program could be offered on a voluntary basis

- Clarification was provided that this document is an internal exercise to ensure that the PESC has done their due diligence and identify any gaps and how those gaps could be addressed
- Issuance of the Information Bulletin No. IB18-016 July 26, 2018, with a link to the Fernie Investigation Report is one way to increase awareness.
- The Fernie report included a lot of good information and recommendations.

The Technical Advisor and Administrator will work on the four-column document for further discussion at the next meeting. [Hantelmann / Poehlmann]

4.3. TCC Report

The Manager of Stakeholder Relations reported the following from the TCC meeting held earlier this week:

- Discussion regarding the Fernie incident, copies of correspondence, the report and a safety video are included in the TCC October 2018 meeting folder on the portal
- RMA and AUMA representatives were asked to create further awareness at the municipal level
- The refrigeration industry is working with the Council to present to the building and pressure equipment sub-councils
- Certification and Permit Regulation was presented to extend the expiry date
- the Gas Sub-Council has submitted a docket to change to CSA that would state that a furnace used for construction cannot be used to heat the building after construction
- Building envelope challenges are being discussed across disciplines
- The Chair of the Board was reached his maximum number of terms and a new Chair is being recruited
- A successful meeting was held with APEGA, AAA, AMA and the Council regarding how professionals and SCOs could work better together

- Other items included the implications of the proposed change for lowering allowable stress values for Gr. 91 materials and potentially review AB-500 documents
