4. Matters for Discussion

4.1. CSA Z98 Drive Upgrade Safety Alert Bulletin

A presentation was made by the Passenger Ropeways Technical Expert on Electric Drive Upgrades. The slides were included in the member portal and reviewed:

- Recent incidents caused by unintended consequences of drive system upgrades have triggered the need for a safety alert.
- The draft safety alert created by the CSA Z98 Technical Committee for Passenger Ropeways and Passenger Conveyors is being reviewed prior to issuance.
- The safety alert applies to owners, managers, operators, suppliers, designers, authorities and persons contemplating or implementing a passenger ropeway or passenger conveyor electric drive upgrade.
- Passenger ropeways generally utilize commercially available drive systems to control motors that power the ropeways. Issues arise because passenger ropeways have unique and specific requirements that are only understood by qualified persons with proper training and experience regarding passenger ropeways. Drive system specialists may be unfamiliar with critical interdependencies between ropeway controls and equipment and the drive system.
- There are hundreds of older drive systems presently in use and many will require upgrades within the next few years. Upgrading these systems is considered a 'major alteration' in Alberta and requires adequate professional documentation and independent expert professional review.
- There are professional practice guidelines that should also be followed when working on these systems.
- The safety alert is split into two parts. Part 1 gives a general overview and includes detailed background information, guidelines for professional engineering associations, applicable regulations, qualifications, and information on older drive systems. Part 2 focuses on technical information and includes basic safety requirements, drive system redundancy, monitoring and supervision, information on breaks, strategies for harm and risk reduction, risk and hazard analysis, failure modes, information on contractors, and examples of possible design errors.

The following was discussed:

- It was noted that this bulletin provides awareness for owners who don't understand who is qualified to do the work and the risks involved with not having the proper professionals involved in upgrading the drive systems.
- The passenger ropeways industry is seeing a departure of experienced workers and new people coming in may be unaware of all the risks with these systems.
- Once finalized, the safety alert will be sent out to ski associations and AHJs.
- The classification of a major or minor 'alteration' is left up to each province.
- It was questioned whether there is a perceived gap in the code that isn't covering or clarifying processes for designs. There are clauses in the code for basic safety requirements and professional standards. It's believed the issue is that owners don't know or understand the code, not that the code itself is lacking.
- In Alberta, regulations and AEDARSA requirements are in place to ensure documentation of the scope of work and that the code requirements are met.

4.2. AEDARSA Report

A written report was included on the member portal and the following was reviewed:

- The 'Compliance Monitoring Program' for 2021-22 report.
 - 33 Permits of Operation generated listing 154 ropeways for the 2021-22 season
 - o 154 in-service inspections were completed
 - 100% compliance monitoring
 - o 11 initial inspections were completed
 - 431 Directives issued to owners
 - 257 Low Severity
 - 107 Medium Severity
 - 67 High Severity
- 19 Accident/Incidents Reported to AEDARSA in 2021/22. AEDARSA did not conduct any onsite investigations.
- Information Bulletins are now updated along with new information bulletins in a standardized format. AEDARSA will be developing a 'new' website to capture all the Passenger Ropeway information and have all the information at one site. AEDARSA will notify Area's when a new Information Bulletin is posted on the AEDARSA website.
 - o IBPR21-001 Reporting of Passenger Ropeway Accidents & Incidents
 - IBPR21-002 Clarification of Alterations
- Due to Covid-19 AEDARSA was unable to present the Alberta Passenger Ropeways Training (APRT) seminar the last year, however was able to provide a 2020/21 Year in review at the CWSAA 2021 Virtual Spring Conference. AEDARSA will be in Lake Louise at the 2022 CWSAA Spring Conference to provide a Year in Review.
- AEDARSA is hopeful to host an Alberta Passenger Ropeways Training (APRT) seminar in 2023 that is open to all owner/operators and industry stakeholders. There will be no cost for this seminar however the participants must pay for their own travel and accommodation.

4.2.1. Update on BC Workshops for vandalism, unauthorized access and cyber security

With the concern of security on the rise, Canada West Ski Areas Association has created a committee around security to discuss various issues within industry.

4.3. Administrator/AMA Report

The Administrator reported:

- Municipal Affairs staff are back in the office starting in April. There is a hybrid program in place for staff to work from home some days.
- There is a new ADM, Shawn Ewasiuk. He formerly held the position of Executive Director and that position is currently vacant with a replacement being sought.
- The Administrative Penalties Program is in force. This program was created to improve compliance through incentives and various penalties.
- With timely code adoption in the passenger ropeways discipline, the sub-council will have one year to review the code before it comes into force.

4.4. Council Updates

A written report was included in the portal and updates were provided on the following:

- The Council office reopened on March 14th.
 - Staff may continue to work from home on some days.
 - \circ $\;$ All meetings that have been identified as tentatively in-person remain so.
 - Staff will contact members prior to the next meeting to ascertain how many people plan to attend in person. If fewer than half of members plan to do so, the meeting will be held virtually instead.

 - Council AGM will be held virtually in the fall along with an in-person volunteer appreciation event.
