4.1. AGM Updates

The following was discussed and a presentation is available in the portal

- Safety Codes Council AGM was postponed this year due to COVID 19 and plans are being made to host it virtually towards the end of October
- Need to hold the AGM to approve the bylaw changes that were recommended as a result of last year's governance review
- A refresher of the recommendations was provided: dissolve the TCC, creation of two new sub-councils for Utilities and Private Sewage Disposal Systems

4.2. Council Education Presentation

A presentation by Kris Schmaltz and Michael Lalonde was included in the portal and the following was discussed:

- The Council is reviewing its approach to education and training in the system and has developed outcomes and principles to guide programming
- Looking for stakeholder feedback on the proposed future direction of building capacity system-wide through shared understanding and knowledge, and any gaps anyone sees regarding education in the system.
- Targeting a broader system-wide audience could improve shared consistency in understanding of roles, responsibilities, and general knowledge in the safety system
- Passenger Ropeways SCOs are a small audience, with access to their own specific training
- SCOs are well known and in frequent contact with operators and each other so there aren't as many issues regarding inconsistencies like in other disciplines

4.3. AEDARSA Report

The following was discussed:

- Presentation from the Canada Ski Areas Association town hall will be uploaded to the portal for members to review
- 1X is running smoothly, they are getting ready to start inspections
- The Sea to Sky vandalism incident was discussed and it was noted that it would be advisable for all ski hills with lifts to review their security and update their emergency response plan

4.4. Administrator/AMA Report

The Administrator reported:

- New Minister of Municipal Affairs, Tracy Allard, has been appointed
- New Director in place, Shawn Ewasiuk, he may attend a future meeting
- 2019 code has been fully adopted and is currently being enforced

- COVID 19 protocols regarding hill openings are under the jurisdiction of Alberta Health, not Safety Codes
- Feedback from industry and government is that parties have been working diligently with health departments and Bizconnect
- New bill was passed for Safety Codes Administrative Penalties which allows the issuance of monetary penalties for noncompliance with the Safety Codes Act up to \$10,000 a day up to a maximum of \$100,000

4.5. COVID 19 Impacts

A discussion was held regarding concerns or feedback in regards to COVID 19 impacts on opening:

- Hills are planning to open as scheduled
- It was noted that local AHS is attempting to introduce measures above and beyond those originally discussed and currently required
- There are concerns regarding impact of increased visitation, emergency protocols and how physical distancing can be adhered to
- Snow Valley Ski Hill moving to a scanned system and limiting times for lift tickets
- Season's pass sales are not quite as strong as normal but there appears to be a good level
 of interest
- There may be some difficulty getting parts or mechanical experts in from some parts of the world
