#### 4. Matters for Discussion

#### 4.1. CSA Z98-19 Review

The new CSA Z98-19 was published in March, and with timely code adoption it will come into force on April 1, 2020. The PRSC will review the new code and make one of the following recommendations: adopt the code as presented, adopt the code earlier, delay the adoption of the code, or not adopt the code at all. Recommendations must have strong supporting rational and should be based on issues or major impacts that the code changes may have on the industry.

Many of the changes in the new code are for clarification. The Administrator will start a 3 column document to facilitate the sub-council's review process.

The Administrator highlighted the new requirement for surface lifts and new magnetic rope testing requirements for T-bar haul ropes. The sub-council was asked to look into the potential impacts of these changes, including the costs, retroactive testing, and how many facilities will be affected.

Small operators will be contacted to assess the impact these changes may have on their operations. [Van Zandt / Eeglon]

Medium and large operators will be contacted to assess the impact these changes may have on their operations. [Haagaard]

The member representing Technical Experts will be contacted to discuss speed requirements for testing. [Roy / Sparks]

The sub-council was asked to circulate any feedback prior to the September meeting.

#### 4.2 Conveyors

The Administrator highlighted the new inspection requirement for new conveyors in the new CSA Z98-19 code, which includes running buttons and stop buttons for maintenance.

#### 4.3 AEDARSA/Incident Report

The AEDARSA 2018/2019 year in review report was included in the portal.

It was noted that there were 21 incidents reported to AEDARSA last season:

- 10 misloads/unloads: 5 at load, 5 at unload ramps
- 4 equipment damage: lightning strike/ carrier hit by snow cat / XY-bolt failure/carrier (bail) failure
- 7 falls from carriers: height range 5.0/3.0/5.0m 4 fell from 'T's

AEDARSA has no concerns with these numbers or the trends of these reports.

## 4.4 AMA/Administrator Report

The Administrator reported on the following:

- The new government has a different mandate and focus on red tape reduction.
- Municipal Affairs administrative penalty program has been put on hold.
- The Alberta editions of the National Building and Fire codes are available free online from the NRC.
- Transitions periods for the new codes has been extended, allowing municipalities and AHJ's to restrict to the 2014 code until December 1, 2019.

## 4.5 Council Updates

The following was reported:

- Starting in the fall, the agenda will be posted two weeks in advance of the meeting;
   all requests for additions need to be submitted to the Chair at least three weeks in advance.
- New Member Orientation will be held on September 24.
- Effective Meetings training will be held on November 12.
- Appeals training will be held on November 13.
- In September, the PRSC will review its matrix and develop a skills matrix for each industry segment.
