4. Matters for Discussion

4.1 2019 Meeting Dates

4.1.1. Meeting Start Time

Consensus was reached that the meeting start time be 9:00 a.m. but for the time to be flexible depending on the agenda.

4.2 Conveyors

It was reported that a Letter Ballot was held by the CSA code committee on changes to CSA-Z98 regarding conveyors. It is expected that the next CSA-Z98 Standard will be publish in March 2019. The proposal submitted to CSA-Z98 was very prescriptive and this has been revised to be more general. It was clarified that with timely code adoption, the new CSA-Z98 would be in force 12 months after it is published.

An overview was provided regarding the changes that will include inspection controls and a mandatory loading control switch, similar to what is used for elevators. It was noted that this would not be retroactive and would only apply to new installations.

It was questioned regarding any recommendations for existing conveyors. No discussion has been held but it was suggested that updating procedures and education should be the first step. Retrofitting existing conveyors with the new CSA-Z98 requirements would be a lot less expensive than following the BCSA Safety Directive. It was noted that the goal will be to encourage updating procedures and education for all types of devices, not just conveyors. Examples were provided of robust procedures that have been put in place to mitigate risk.

An in-depth discussion was held regarding how the new revisions are anticipated to increase safety. This item will remain on the agenda until after the review of the new requirements.

4.3 PRSC Matrix – Conveyors Nominating Organization

The current matrix policy was included in the portal and reviewed. A discussion was held regarding the industry segment and whether revisions are needed. It was suggested that this be deferred for the time being.

It was noted that the matrix has been revised so that the Risk and Insurance Management

industry segment's nominating organization be the Risk and Insurance Management Society.

4.4 AEDARSA/Incident Report

An overview was provided of an incident that involved a lightning strike on an operating lift.

4.5 Administrator/AMA Report

Other than work being done relative to CSA-Z98, there was nothing further to report.

It was suggested that this would depend on the impact to industry on the new changes for conveyors and non-destructive testing.
