4. Matters for Discussion

4.1. Pressure Equipment Sub-Council Draft Recommendation on Refrigeration Systems

A Fernie investigation report was included in the portal, along with excerpts from the PESC minutes. The Sub-Council was asked to review the recommendations from the PESC to provide feedback on whether there is support or any concerns.

The Plumbing Sub-Council had no concerns with the recommendations and believes that it will greatly assist the refrigeration industry. From the Plumbing Code perspective, there were no challenges or conflicts.

4.2. Reference Standards

4.2.1. NSF

The following was reported:

- NSF 40 is in the process of summarizing the recent survey results
- Changes to other NSF documents are ongoing
- Hopefully more updates will be available by the next meeting
- An overview was provided of work being done relative to Waste Water Package Plants
- Work is being done to address the many overlaps between Standards
- An update was provided on CAN/BNQ 3680-600 Onsite Residential Wastewater Treatment Technologies

The led to a discussion regarding the CETA Agreement and the forthcoming challenges regarding construction products manufactured in Europe and certified to Canadian standards. Although not a lot of plumbing products are being seen yet, the number is expected to increase. The increase in certification labels with Canadian identifiers will present a challenge for SCOs. CIPH has one of the best list of labels, but there seems to be a disconnect on the international level. Currently, SCOs who are unsure about certification marks can contact AMA for assistance.

It was further reported that the Standards Council of Canada is encouraging participation relative to world standards development and this will be challenging for standards organizations to manage. Requests may come forward to see if there is interest in participation at the international standards level.

4.2.2. ULC

There was nothing new to report.

4.2.3. CSA

The following report was provided:

- Work continues at a rapid pace relative to CSA-B214—Installation Code for Hydronic Heating Systems
- CSA-B66—Design, material, and manufacturing requirements for prefabricated septic tanks and sewage holding tanks is in mid-cycle
- An update was provided on public consultations

4.2.4. ASSE

There was nothing additional to report.

4.3. NPC 2020 Working Group Report

The Working Group is continuing to review the proposed changes. These cannot be put into a 3-column document yet until the changes are finalized. Members were welcomed to remain after the meeting to continue reviewing the changes.

4.4. PSDS Working Group Report

There was nothing new to report as the last meeting was postponed to June.

4.5. AMOS Report

Mark Harrold reported the following

- The recent AMOS meeting went very well
- New President Rick Baxter
- Kevin Wong did an excellent presentation on Legionella
- Public Speaking Seminar was excellent
- Unfortunately AMA was unable to attend because of the Elections Act
- AMOS meetings seem to be more successful since adding educational courses because employers are seeing greater value in sending their SCOs

A request from a member was received regarding drainage of elevator pits and the belief that a sump and backwater valve should be required in this specific case because it drains into the sanitary system. The Administrator reported that AMA's interpretation is that a sump is required to protect the elevator but there is always opportunity for the AHJ to consider a variance if an equal or greater level of safety can be proven.

4.6. AMA/Administrator Report

The Plumbing Administrator's written report was included in the portal and an overview was provided on the following:

- NPC 2020 being developed by NRC's Plumbing and HVAC standing committee and an update was provided from their annual meeting in Halifax in mid-April
- Public consultation was completed in the Fall 2019 and feedback reviewed by the standing committee; a lot of feedback on water reuse and rainwater harvesting
- Water reuse public consultation
 - Water Reuse and Resource Recovery in Canada Quarterly Project Update was included in the portal
 - Once Guideline publication is completed, this will likely trigger changes to the website and STANDATAs
- Scope of plumbing systems
 - All activities with plumbing and drainage on a single property including irrigation unless regulated by other ministries
- The Council has included a direct link in the portal to the safety codes section of the new AMA website
- Relaxing code vs variances/Alternate solutions
- ABS drainage totally encased in spray foam may result in fracturing due to expansion and contraction
 - Photographs were shown of ABS drainage failures and further investigation is being done to determine the root cause but too early to make any assumptions

The Private Sewage Administrator reported the following:

- The major focus right now is on the SOP; there will be a lot of work to amalgamate the Handbook and the SOP and a 4-column document is under development
- Four approaches are being taken with the handbook material:
 - Should a code change be made
 - Should further clarification be listed in appendices
 - Some are education resources
 - Some could be considered training material
- Feedback has been provided to the Council's training department regarding revisions to course material
- A lot of information about new technologies has been brought up
- Continuing to work with the Certification Review Committee

 Continuing to work with local authorities regarding variances, a final date has still not been determined regarding when the responsibilities will shift to the accredited municipalities

4.7. TCC Report

The Chair reported that he was unable to attend the last TCC meeting. The Council provided a brief overview of the meeting. More details can be found in the draft minutes posted in the TCC March 5th meeting folder in the portal, which is viewable for all Council members.

4.8. Council Updates

The following was reported:

- New Minister of Municipal Affairs was just announced Kaycee Madu
- A brief update on the Conference was provided
- Starting in September 2019, the agenda will be posted 2 weeks in advance of the meeting; all requests for additions need to be submitted to the Chair at least 3 weeks in advance of the meeting.
- PSDS Working Group was postponed and is now scheduled for June 5, 2019

4.9. Plumbing Insights from Other Countries

The Chair provided a presentation on screen from his recent trip to Uganda for work on College and Vocational Technical Institute partnerships. The presentation included photographs of various construction practices for plumbing and building.

Some observations included:

- A lot of pipe bending done by hand both galvanized and polypropylene
- Use of galvanized fittings with polypropylene piping
- Open fire kitchens
- No public water supply system

Photos were also shown from the trade show and plumbing skills competition at ISH in Germany, including unique plumbing fixtures and ways to ensure there are no dead end lines in potable water systems.

4.10 In-Camera Discussion

An in-camera session was held. After the in-camera session, the following recommendation was brought forward.
