4. Matters for Discussion

4.1. Permit Regulation Update

It was reported that nothing has been seen yet relative to the Permit Regulation. A plumbing permit has no relationship with the water/sewer connection. It was suggested there was an opportunity to clarify the exemption as many municipalities are struggling with this.

The Chair will gather further information to bring this matter forward to the Technical Coordinating Committee. [Hughes]

4.2. Installations

The Chair reported concerns on behalf of the Canadian Institute of Plumbing and Heating. The ABC 2014 – Section 9.36 Prescriptive Energy Efficiency Requirements for Houses is having a significant impact on the hydronic heating industry, specifically in-floor heating systems. These new energy requirements go well beyond the requirements of CSA B214.

This new requirement will only save about \$25.00 per year for a 1,500-square foot home. Installation of 4" thick insulation will take up to 147 years to recover costs. The Return on Investment isn't there.

Hydronics Industry is feeling unjustly targeted. Based on a recent poll of the industry:

- 77% decrease overall
- 90% decrease for new installations
- 95% has affected their industry

CIPH is looking for a relaxation of the code of the R25 energy code requirement. Electrical in-floor heating would have the same requirements.

The Hydronics industry would like a Variance STANDATA to be issued by the Building discipline. Clarification was provided that a Variance would need to address equivalency in safety and energy efficiency, not a relaxation of a code requirement. A recommendation for a change to the code would have to go to the Minister.

The Chair will bring forward these concerns at the next Building Sub-Council meeting. [Hughes]

4.3. Requirements for Combination Heating Systems: Dual Purpose Water Heater STANDATA

There was nothing new to report.

4.4. Draft STANDATA Review

4.4.1. Radon Soil Gas Vent Termination

The draft STANDATA (Building Interpretation / Plumbing Information) was included in the portal and reviewed. This work is typically done by plumbers but the permit is issued by the Building discipline. A brief update was provided regarding the prescriptive requirements for piping and labeling that the City of Lethbridge are requiring. Some push back is being experienced. There was no objection to supporting the STANDATA.

4.4.2. Radon Pipe Labelling

The draft STANDATA (Building Interpretation / Plumbing Information) was included in the portal and reviewed. There was no feedback to pass along to the Building Sub-Council and no objection to supporting the STANDATA.

4.4.3. Mobile Cooking Operation Joint Interpretation

The Mobile Cooking Operations Joint Interpretation (Building, Electrical, Fire, Plumbing and Gas) was included in the portal and reviewed. It was noted that there is not much relative to plumbing. It was reported that 79% of incidents are propane related. Although some jurisdictions do not look at food trucks, this interpretation says the code does apply.

There was no objection to supporting the STANDATA.

4.4.4. Composting Toilets

The draft Building STANDATA was included in the portal and reviewed. There was no objection to supporting the STANDATA. It was noted that this is intended to be for interior systems but there could be some impacts to the Private System discipline or Alberta Environment.

All feedback regarding all STANDATAs should be forward to the Chair and the Administrator. [All]

Any STANDATA feedback will be provided to the Building Sub-Council.

4.5. Plumbing Code Questions

It was reported that discussions are being held at the National level regarding 2.7.1.1. as almost all jurisdictions interpret non-potable should not be connected to potable water supply as non-directional. However, Alberta has always interpreted it as meaning both ways — cannot connect non-potable to potable and cannot connect potable to non-potable. Alberta is now being advised that you can connect potable to non-potable.

It was reported that there is confusion regarding venting emergency floor drains. It was clarified that all floor drains, including emergency floor drains, require a vent.

4.6. NPC 2020

The following three issues will be discussed by the working group after the meeting, if time permits:

- 2.6.2.4. Backflow from Fire Protection Systems relative to F valves
- Legionella issues and water temperature work being done by the Technical Committee
- Report from Task Group on Water-use Efficiency

The next review of proposed changes could be available as early as September 1, 2017.

The following items are also being looked at by the technical committee:

- Cisterns
- 2.6.2.5.(1) Separation of Water Supply Systems
- Reference of new Rainwater Harvesting Standard
- 2.1.2. Service Connections

A 3-column document will be available including all changes.

It was reported that a technical committee has been established for basement floor protection to create a standard for back flow protection including heights of basements, window wells, what houses shouldn't have basements, etc. A participant from Alberta was requested and Mark Harrold volunteered.

- Items being addressed by Pressure Vessels SC

Mark Harold reported on the AMOS meeting held last week:

It was reported that AMOS would like to have a clause added to the STANDATA regarding Grease Interceptors. This was provided to the Plumbing Administrator for consideration.

4.9. PSDS Administrator Report

4.9.1. Stay of Orders Process

A brief discussion was held regarding Stay of Orders. It was noted that this is typically reported back to the Chair. It was clarified that this was likely just an oversight as the individual in the position is quite new to the role.

An overview was provided of the appeals process and the two paths that can be taken. New members were encouraged to take Appeals 101 when available.

4.9.2. Probational Status of SCOs

Confusion was expressed regarding probational certification for SCOs. It was explained that this is included in the Council's Probationary Certification Policy 4.120 is available at:

4.9.3. PSDS Handbook

It was reported that a contractor has been hired to work on the PSDS Handbook. The PSDS Administrator has been reviewing the changes. The final draft will be returned to AMA for final review before being published.

July 1, 2017 has been established as the final deadline.
