4.1. Governance Review

The Manager of Stakeholder Relations provided a high-level overview of all the work that has been done on the governance review, starting with the Board.

Briefing notes were included in the portal, an overview was provided of the existing bylaws and a series of questions were asked to gather input.

A round table discussion was held, and input was provided on a variety of areas including:

- What the TCC and the Sub-Council's roles should be
- How code adoption should flow
- How often the TCC should meet
- TCC membership
- How the Council should address Energy Codes

It was reported that New Member Orientation and Appeals Training are coming up and members were encouraged to take these workshops if they haven't already done so.

An overview was provided on how the letter ballot process is being revised to align with Council bylaws and governance best practices. Letter ballots will be used in the future only at a last resort if no discussion is needed. Conference calls will be utilized and additional meetings may be necessary.

It was explained that every sub-council member can view all sub-council and TCC folders.

Working Group members that are not sub-council members are limited to seeing only their Working Group folder.

More communication is being held with nominating organizations to ensure the right representatives are on the sub-council and bring the necessary skills.

An overview was provided of the following Next Steps:

- This same presentation will be provided to gain input from each sub-council
- A summary report will be provided on what was heard from the Technical Coordinating Committee as well as all sub-councils
- A draft Terms of Reference will be developed for the TCC and each of the sub-councils for review at a future meeting
- Changes will be anticipated to the bylaws
- Survey in the fall to gather feedback

4.2. Understanding Government Policy

A presentation was shown on screen regarding Understanding Government Policy and included in the portal for reference. Highlights of the presentation included:

- What Policy is
- Government is best defined as the Executive Branch (Cabinet)
- Government Policy Authority comes from the Constitution and Acts
- Acts allow the government to take action through many tools including Regulations and Operating Policies
- An overview was provided on:
 - How Government Policy is developed
 - How policy makers determine which policy to use
 - How laws are created
 - How Government decisions are made, including the Flow Chart used for making decisions
 - How laws are drafted
 - What the Department does
 - How the Council fits in for Safety Codes Policy
 - How the Council and the Government can work together
- It was emphasized that the Minister is ultimately accountable for making the decision

Background was provided, and a volunteer was requested. There were no volunteers, and the Council will continue to pursue this via email including those not in attendance at the meeting.

4.4. Draft Variance Guidance Notice & Template

A presentation was provided on Variances. It was explained that there is an unproclaimed section of the Act that would allow for an appeal of a denied variance. It was recognized that there is a need to clarify the use of variances before that section of the Act could be proclaimed.

Highlights of the presentation included:

- Purpose of Variances
- Why this is being raised
- What a variance is
- What a variance is not
- The expectation of an SCO when a variance is requested
- Why a variance is issued
- The expectation of Registered Professionals
- Outstanding issues include jurisdiction-wide variances and discipline specific issues
- An overview was provided of the next steps

The following was included in the portal as information:

- Variance Presentation
- Safety Notice Expectations and Guidelines for Safety Codes Officers Respecting Variances
- Sample Variance Form Template

It was questioned regarding multi-discipline variances (e.g. PSDS and Plumbing) and what should occur if there is disagreement with a variance. If there is disagreement, it was suggested this should be discussion directly with the proponent. It was questioned if someone asked for a variance under say the Plumbing Code, but the SCO believes it should be under the Private Sewage Code, this should be discussed directly with the proponent and technical expertise could be sought from the Administrators.

With regard to Professional Involvement, it is still the variance proponent's responsibility to demonstrate that the alternative provides an equal or greater level of safety. This led to a discussion regarding complex projects and the need to have Professional Involvement. Once this section of the Act is proclaimed, this could be appealed but the proponent would need to provide rationale to explain why Professional Involvement isn't needed.

It was questioned about a date regarding changes to policy and there is no concrete date at this time.

It was reported that the work done by the Gas and Plumbing disciplines is relative to variances that can only be issued by the Administrator regarding material, uncertified equipment and reduction of clearances. The work done under the Standards Council of Canada is a different process and the use of the term "variance" will be changed to a VTR (Valid Technical Reason) for

field approval of one specific piece of equipment at a specific location. This will be managed and audited by the Standards Council of Canada.

A report was provided on behalf of the Working Group. The setback distance is a priority area being looked at by the Working Group to ensure that the information included in variances is consistent. It is hoped this work will be completed by the end of 2018. It is hoped the working group's work with greatly assist the Rural Municipalities of Alberta.

4.5. Plumbing Administrator Report

The Administrator reported the following:

- NPC 2020 being developed by NRC's Plumbing and HVAC standing committee; an overview was provided regarding some of the challenges and heavy workload
- Scope of plumbing systems was explained, all activities with plumbing and drainage including irrigation unless it crosses the property line
- Sizing roof drainage was shown as an example

4.6. PSDS Administrator Report

The PSDS Administrator reported the following:

- Gratitude extended to the working group for all of their hard work on the SOP Handbook
- Consideration was requested for having the handbook amalgamated into the Standard of Practice and members were asked to give this some thought and provide feedback to the Administrator
- Getting good buy-in for incident reporting by SCOs since the incident form was created
- There was a recent fatality in the industry and an incident investigation was held
- Three PSDS installer certificates of competency were suspended
- Although it was believed that a separate Council email was used for proposed code changes, this could not be found. All proposed code changes are being forwarded to the PSDS Administrator.
- An overview was provided regarding Fort McMurray rebuilds where the rebuilds are much larger than the system was designed for

It was questioned whether a homeowner could take designer training. It was reported that some homeowners have done this. It was reported that the training is about 10 days.

4.7. PSDS Working Group Report

It was reported that the handbook has now been completed. This 500-page document was reviewed at 3 working group meetings. It was noted this is used by a lot of instructors. As noted previously, the Council was thanked for all of their work with the Working Group to get this document completed.

With this being Charles Hallett's last meeting, there is need to appoint a new Chair of the working group.

Charles Hallett / Peter Koenig moved to appoint Angus Potskin as the Chair of the PSDS Working Group; CARRIED

4.8. NPC 2020 Working Group Report (working group meeting in afternoon)

A brief overview was provided on the review that is being conducted by the Working Group of the NPC 2020. It was requested that a folder be created for this Working Group on the portal.

4.9. Draft Update to Floor Drain Trap Seal STANDATA

The STANDATA was shown on screen. The primary change includes the following:

Other products identified as a trap seal device certified to ASSE 1072 Performance Requirements for Barrier Type Floor Drain Trap Seal Protection Devices, that limit trap seal evaporation, must also maintain an effective water seal by manual or automatic replenishment depending on the type of installation.

Peter Koenig / Quenton Kusiek moved to support the publishing of the Draft Update to the Floor Drain Trap Seal STANDATA, as circulated; CARRIED

4.10. Reference Standards

4.10.1. NSF Code Development

It was reported that there has not been a recent NSF meeting. A brief update was provided on some of the topics of discussion and a report will be provided at the next meeting.

The PSDS Administrator also reported on the following:

- CSA B126 Standard has come up for re-affirmation, cisterns will require certification
- CSA B805 Rainwater Harvesting is the best current standard that is compatible with the Canadian Safety System

4.10.2. CSA Committee on Basement Floods

Mark Harrold reported that the committee has completed its work and the Standard has gone to public consultation.

A brief update was provided regarding the ULC Standard for Backwater Valves and the

questionnaire relative to climate change. It was recommended that this be added back to the agenda. [Council Administration]

4.10.3. Draft Updated Standards STANDATA

The draft multi-discipline Variance STANDATA was included in the portal and reviewed. This was provided as information at this time. Members were asked to review the document, take it back to their nominating organization for feedback so that further discussion can be held in the fall from both the plumbing and private sewage discipline perspectives.
