1. Meeting Opening

The Chair called the meeting to order at 9:01 a.m. and a round table introduction

1.1. Agenda Adoption

- 2. Matters for Decision
- 2.1. Training Course Validations

2.1.1. Plumbing, Group B, Private Sewage Treatment Systems, Alberta Private Sewage Systems Standard of Practice 2015 (Course ID #100150)

Charles Hallett reported on his work reviewing the examination which brought forward issues with the course material and the need for both minor and major revisions. Any revisions will take time and it was suggested to move forward with this current material until these revisions can be completed.

When feedback was provided to the Council, quick fixes were incorporated but for major revisions, it was asked if they could be held off to the next code cycle. It is believed there is an opportunity to provide feedback to the Council on the gaps that exist. It is likely that the revisions would take up to a year to be completed.

With there being no course material available to SCOs based on the Private Sewage Standard of Practice 2015, it was suggested this was better than not having anything available. However, it was believed there is still an opportunity for further discussion with the Council regarding the processes for the sub-council providing feedback on course and exam materials, making changes to the materials, and validating courses.

After an in-depth discussion, the following decision was made.

Charles Hallett / Peter Koenig moved to approve the training course material for the Plumbing, Group B, Private Sewage Treatment Systems, Alberta Private Sewage Systems Standard of Practice 2015 (Course ID #100150) for use until September 2018, based on the understanding that a contractor will be hired to correct and enhance the course material and examination questions to better reflect the 2015 Standard of Practice; CARRIED

4. Matters for Discussion

4.1. Plumbing Code Questions

There were no new questions to be brought forward from the educational institutes.

Quenton Kusiek reported that he has received questions from two architects regarding NPC 2.4.10.4. – Hydraulic Loads. It was clarified that the roof needs to be able to handle the load. It was suggested that a written request for interpretation be submitted to the Chief Plumbing Administrator so a formal clarification can be provided. [Kusiek]

A proposed code change has been forward to the National level to add a definition for *continuous vent*. This will be included in the portal as information. [Hughes]

The Chief Plumbing Administrator asked the technical institutes to provide direction regarding RV dumping stations. [Helmer]

4.2. NPC 2020

It was reported that a public consultation is expected between now and December 2017 on this current round of proposal code changes. One more round of consultation is anticipated before the final cut off for changes to the NPC 2020.

It was reported that the greatest changes are expected relative to water reuse, including rain water harvesting. However, it is likely that if the section on water reuse does not go to public consultation now, it will probably be delayed to the NPC 2025.

4.3. PSDS Administrator Report

4.3.1. Review of STANDATA Notice

The PSDS Administrator reported on a PSDS Notice published recently highlighting:

- Final Notice that August 1, 2017 is the Deadline to Obtain 2015 Standard of Practice (SOP)
 Update Training Required for Renewal of a Private Sewage Certificate of Competency
- New Initiative: Certification Review Committee
- New Initiative: Private Sewage Working Group

This Notice is available in Shared Documents in the Plumbing Sub-Council portal.

4.3.2. Certificate Review Committee

It was reported that the Certification Review Committee (CRC) has provided direction around training deadlines, additional training competency requirements for certification renewal and has reviewed a number of issue files to provide direction for action on certification. The CRC will also be assessing the needs for continuing education around certification competencies and the training requirements that assess competency prior to certification issuance.

4.3.3. PSDS Permanent Working Group

The Working Group Chair provided a brief overview of discussions from the Working Group's first meeting, including that the working group will be developing a recommended process on how proponents can apply for consideration of new technology that does not meet the existing Standard of Practice.

The recommended Terms of Reference will be sent to sub-council by Letter Ballot for validation. [Hallett / Council Administration]

4.4. Reference Standards

Members were reminded that participation on national standards committees is highly encouraged. This item will be included on future agendas for any updates relative to reference standards in the NPC. [Council Administration]

4.4.1. NSF Code Development

The Chief Private Sewage Administrator advised that a Code Development Committee meeting is scheduled for next week. The committee believes that it would be extremely valuable to have the Chief Administrator's participation.

4.4.2. CSA Committee on Basement Flood Remediation

The Chief Plumbing Administrator reported on work being done at the committee level regarding basement flood remediation.

4.5. AMOS Update

The Fall AMOS Meeting will be held October 20-21, 2017. It was reported that B149.3 training will be provided on Friday morning.

4.6. PSDS Handbook Update

It was reported the SOP Handbook has been sent back to the contractor to be cleaned up and a revision should be available this week. This item was removed from the action list and will be reported on by the Working Group.

4.7. Discussion on Air Admittance Valves

The first version of a potential STANDATA on Air Admittance Valves in New Construction relative to NPC 2.5.9.2.1.(d) was viewed on screen. There is a need to provide clarification as there are inconsistencies across jurisdictions and the term "practical" is very subjective. Although many do not want to allow the use of air admittance valves, they are permitted within the code and there is no evidence of failures to move forward with changes to the code.

It was explained that there are other venting systems that are not allowed to be used in Canada because there is evidence of failures and fatalities.

The draft STANDATA will be presented to AMOS at their fall meeting for feedback. [Harrold]

4.8. Potential STANDATA Development regarding Temporary Construction Heating

It was reported that, as of May 1, 2017, furnace manufacturers have stated that if their residential furnace is used for temporary heat during the construction of a single-family home, the furnace's warranty is void. This is because drywall dust seems to cause most of the warranty work.

The draft STANDATA was available for those interested from the gas discipline perspective. The STANDATA includes a template for industry to manage the process and activation of the furnace.

4.9. Other Equally Effective Means for Floor Drain Trap Seal Protection

It was reported that all current barrier type floor drain trap seal protection devices certified to ASSE 1072 would be considered as an appropriate alternate for the local authority to utilize when considering other equally effective means for protection of floor drains. A document was shown on screen that could be developed into a STANDATA. This document will be included in the portal for review. [Manning]

Concern was expressed regarding these devices being clogged up and it was clarified that there are manufacturer requirements for maintenance.

4.10. Status of Restricted Certification and Certification with AMA (Installers)

The draft notice was shown on screen regarding renewals. An overview was provided of the changes.

It was reported that restricted certification for Sewer and Water Service (R) is being audited for termination. AMA will be working with the Council as this would affect certification. It will affect industry because municipalities would no longer be able to require this restricted ticket.

This item was introduced at this meeting for further discussion. Status of Sewer and Water Service Restricted Certification Update to be included on the next meeting agenda.
