4. Matters for Discussion

4.1. Trade Off for Sprinklers BSC working group presentation

This working group was created to review the NBC and complete a document review of all areas where fire sprinklers provide a current trade off for the other safety construction requirements. A proposed code change request was developed to allow for residential construction allowances where fire sprinkler systems are installed. The recommended code change request was presented and the following was discussed:

- BSC members raised concerns at their meeting about the possibility of a garage within proximity of an exit so an additional comment has now been included to address those concerns
- Plan to submit early next year for inclusion in the 2025 national code

- FSC members are asked to review the document further in depth and supply comments directly to the working group chair [All]

Cammie Laird/Joe Davis moved to support the intent of the code change request proposed by the Trade Off for Sprinklers working group with comments; CARRIED.

4.2. Working Group Reports

4.2.1. Code Review

The following was discussed:

- Work has started on a portion of the items on the list: there are a large majority which the group is suggesting to keep in some form, approximately 6 where they agree on harmonization, and approximately 5 that have no consensus
- Aim to have finalized the review by the next FSC meeting
- The Administrator indicated that there is a tight timeline with little room for turnaround time, will need to have the recommendations no later than April 1st, 2021

4.3. BSC Liaison Report

The BSC Liaison reported:

- Using Stopped Escalators as Stairs working group presented their report and found it cannot be done safely, they recommend building owners go to manufacturers if they want to explore the topic further
 - Sprinkler Trade Offs working group presented and received very positive comments overall
 - Discussion regarding farm buildings and the ongoing concern regarding the misuse of the designation. FSC members agree this is an issue and are happy to provide any necessary assistance on the topic. The Chair requested the Administrator to provide any statistics on fire losses in rural areas

4.4. Administrator/AMA Report

The Administrator reported:

- Administrative penalties for safety codes infractions are now in place, work with your QMP manager to enforce
- STANDATA for fire suppression and exhaust is being revised to include ventless fryers
- STANDATA for use of containers will come to members for review in December
- Occupant Load and Qualifications STANDATAs are still being reviewed internally
- Screening underway for the vacant Public at Large seat

- While there was a title change at the office of the fire commissioner, the work is ongoing and there have been no changes in service delivery

A written report was included in the portal and updates were provided on:

- Office is still closed to the public and staff are currently working from home again
- New website has launched, being updated regularly and programs and services are being offered remotely
- 2021 meeting dates are in the Member portal
