4. Matters for Discussion

4.1. 19-BCV-019 Interior Stairways for Roof Access to HVAC Equipment

There is confusion in industry around interior stairways for roof access. Initially it was suggested that the paramountcy clause in the Gas Code Regulation would take effect in this situation. However, because the item in question is not addressed by both the building and gas codes, the paramountcy clause does not apply. The Building Administrator is reviewing options for a code change request to the National Building Code to incorporate the roof access provisions that are in CSA B149.1. The Gas Administrator recommends the sub-council put this issue on hold, pending direction from the Building Administrator.

4.2. Working Group Reports

It was noted that Municipal Affairs has updated 3 column documents for all working groups. CSA B149.1/.2/.3 all have new documents for working groups to review. CSA B149.5/.6, B108 and B109 are on different cycles and being monitored by Municipal Affairs. Documents will be developed as information becomes available.

4.2.1. CSA B149.1 / BNQ 1784 Canadian Hydrogen Installation Code

The working group was reminded of their task to review the changes between the 2007 and 2022 editions of the Canadian Hydrogen Installation Code to assist the sub-council in developing a position on adoption of the 2022 code. Municipal Affairs has created 3 column documents to assist the working group in reviewing changes. As this code has never been adopted in Alberta and the hydrogen industry is new, the working group may require outside expertise and should inform Council staff if additional resources are required.

Council staff will help arrange a working group meeting in order for a recommendation to be brought forward to the next GSC meeting. [Council Administration]

4.2.2. CSA B149.2 / CSA B108.1 & CSA B108.2

The following was discussed:

- A federal committee meeting was held for CSA B149.2 with six requests for change being reviewed and two of those being adopted.
- DME (Dimethyl Ether) is a topic of discussion with activity at the world LPG level.

4.2.3. CSA B149.3 / CSA B149.6

CSA B149.3 met in October with no further updates.

4.2.4. CSA B149.5 / CSA B109.1 & CSA B109.2

No update.

4.2.5. Single Family Residential Dwelling Definition

The working group's last meeting involved representatives from BSC, PSC, ESC and GSC with feedback being brought forward from each discipline. No specific issues have been identified other than differing approaches across municipalities. While it has been recognized that inconsistencies can be an issue, there is the ability for each municipality to make a determination for their jurisdiction. Therefore, this topic is considered closed by the working group. However, this topic could be addressed in the future if needed and members were encouraged to bring forward any issues occurring in the gas discipline in their jurisdiction that arise from the interpretation and application of this term.

The action item will be closed, but the working group will be left open until the chair of the working group is in attendance.

4.3. AMOS Report

No update.

4.4. Administrator/AMA Report

A written report was included in the portal and The Administrator provided updates on the following:

- A meeting was held with the Federation of Gas Coops and there were no issues for recognizing installers.
- The Agricultural Gas Engine Variance has support in principle and will be moved forward through the STANDATA review process.
- The Shipping Container STANDATA has been previously discussed at the GSC and is moving forward through the review process with minimal gas discipline significance.
- A working group has been created with PTAC and NPSAC to review the gas fitter
 reconciliation agreement. The agreement creates an expectation across the country that
 gas fitters from other jurisdictions would be accepted. A further update is expected in
 the spring.
- The Canadian Propane Association (CPA) has reached out to the PTAC and NPSAC working group with challenges between provinces with when a permit is required and concerns with potential duplication and unfair practices.
- There have been challenges with the hydrogen and natural gas blends with cross ministry groups reviewing these challenges. There is a hydrogen code but no reference standards, which makes it difficult to connect hydrogen to appliances. Currently, the cross ministry groups are utilizing international standards and harmonizing with other standards.
- CSA put out a whitepaper on the use of hydrogen and natural gas mixtures in products
 certified for natural gas in Canada and the US. The document states that no amount of
 hydrogen can be blended with natural gas while maintaining requirements of the
 existing standards. This is causing major issues with various pilot programs across the
 country, including ATCO's Fort Saskatchewan pilot which has now been paused. CSA has
 stated that appliances certification will be voided if hydrogen is being used in any
 capacity.
- Members were shown how to subscribe to CSA to receive updates.

4.5. Council Updates

A written report was included in the portal and updates were provided on the following:

- The Council will be holding a holiday open house in December for members and other stakeholders; email invitations have been sent.
- The Council office will be closed from December 24-January 2 inclusive.
- The Council has recently issued a cyber security policy which will be sent out shortly to members.
