

Apply for Storage Tank System Removal and Work Permit

This walks you through the steps to apply for a storage tank system removal and work permit

How to Submit Your Application


1. Go to the Safety Codes Council website <https://www.safetycodes.ab.ca/>
2. Select the **eServices** tab to take you to the home page, or alternatively use this link <https://eservices.safetycodes.ab.ca/>
3. Click Sign In or Create Account from the left hand menu
4. Complete all required sections on the application form
 - a. *You have the ability to save the application at any point by using the save as draft button at the bottom of each page, then return and complete it at a future time/date.*
5. Authorize and sign application
 - a. *You can decide not to make the payment at this point, and return at a later time/date to add the payment going through the “My Financial Transactions” section, to cancel the payment at this point, follow the steps below;*
 - i. *Select the “Cancel” button*





- ii. *Confirm that you will like to cancel the payment process at this moment*



- iii. This will redirect you to the **“My Financial Transactions”** page,
 - 1. You can access this page anytime from the left hand menu
- iv. To make the payment from this page, follow the steps below;
 - 1. Go to the My Open Invoices section
 - 2. Identify the application to be submitted
 - a. The payment status on the application will be **“Pending Payment”**
 - b. The invoice can be printed out from this section
 - 3. Select the Add to Cart button on the application
 - 4. You will be redirected to the checkout page
 - 5. You have the option to make the payment or cancel and return at a later time
- 6. Select **“Submit & Checkout”**
- 7. This will redirect you to the payment page
- 8. Complete the order/billing information
- 9. Select a payment method
- 10. There are a number of available payment options, and the one available to you may differ as per the instructions below;



a. Credit card:

- i. This payment option is available to all logged in users
- ii. Using this payment method will submit your application immediately the payment is made on eServices
- iii. You will receive a confirmation email when the application has been successfully submitted.
- iv. This application can be found on the **“Submitted Application”** section on the eServices home page after payment has been made
- v. Credit card payments have a max limit of \$2,500.00.
 1. Any payment higher than the \$2,500.00 limit, will need to be made via cheque or EFT.



- b. **Application Date:** This is date the application is created. This data is auto-populated, and cannot be modified by the Applicant.
- c. **PO/Reference:** If your organization has an internal PO/Reference number, this can be captured on this field, or left blank if none.
- d. **Municipality:** This is the municipality that was selected while initiating the application, and is the location where the project will be located. This data is auto-populated and cannot be modified by the Applicant.
 - i. *If the incorrect municipality is selected, the user must go out of this application, and initiate a new application.*
- e. **Permit #:** A temporary number is provided when you create your application, and this number will be updated if the permit is approved
- f. **Permit Applicant:** Select who is applying for the permit. This can either be the same or different from the requestor
- g. **Search Company:** This search option will list all the available companies on eServices. If the company cannot be found within the search, it can be entered manually within the "Applicant Company" field
 - i. *Search company field will provide suggestions as user starts to type in the details, and will narrow down the list based on data entered into the field*
- h. **Applicant Company:** This is the Applicant's company name.
 - i. If the company is found and selected from the search field above, the data in this field will be populated
 - ii. The company name can be entered or updated manually within this field if the

4. Project Location:

- a. **ASCA Site # (If Known):** This is the site number/ID.
 - i. If you have an existing site, and you know the site number, as you start typing in the number, you will be provided with suggestions and will narrow down the list based on data entered into the field
 1. *If you select an ASCA site number from the list, the details for fields B-G will be auto-populated.*
 2. *If the data within any of the auto-populated fields is incorrect, you can update it manually*
 3. *If you do not know ASCA site number, leave this field blank. However, all the information from **fields B-T MUST** be completed where applicable*
 - ii. ASCA Tanks will assign a site number for new sites once the application is processed.
- b. **Search Site:** This search option will list all the available sites on eServices.
 - i. If the site cannot be found within the search, it can be entered manually within the "Site name" field
 1. *Search site field will provide suggestions as user starts to type in the details, and will narrow down the list based on data entered into the field*
 2. *If you select a site from the list, the details for fields C-K below will be auto-populated **where applicable***
 3. *If the data within any of the fields is incorrect, you can update it manually*
- c. **Site Name:** This is the name of your site. If you select a site from the pre-defined list, it will be filled in by default. If the site cannot be found with the search, it can be entered manually.
